- Secondary education for building life projects.
- Towards eradicating illiteracy and closing inequalities.
- Intercultural and bilingual education program.
- Higher education as a right.

Additionally, the project complies with the mandates established in Law 715 of 2001. For this reason, the Ministry of National Education reiterates its willingness to formalize this collaboration by signing a Memorandum of Understanding (MOU) with the Qatar Development Fund, considering that this step will strengthen the shared commitment to advancing educational opportunities for Colombian youth.
