**With the purpose to facilitate the purchases process, components maintenance and/or repairs, and avoid SATENA or providers heritage loses, we requires consider the next information:**

**Delivery terms:** All quotes shall be consider Incoterms FCA Miami delivery terms (unless another modality is indicated by SATENA). No additional values will be billed related to freights fees about the offered product.

**Warranty:** All overhauled or repaired products must have a minimum of 6 months or 1.000 FC of guarantee by defects related with the reparation/overhaul performed. For new products, must have a minimum warranty of 12 months.

**Traceability:** Please take in account the attached table with the required documentation for each one of the required products.

**Shelf life/ Life limit:** For supply of chemical products, consumables, paints, etc. For those that have been established with useful life, delivery must be made with a minimum of 80% of remaining life limit for use.

**NOTE:** Only in exceptional cases, notified by SATENA representative, elements may be received with no accomplishment of this requirement.

**Measurement units:** For quote process of materials as Paints, chemical products, consumables, it must be considered as indicated in the request. If the provider has not have available the requirement in the specified measurement units; this one must notify the offered measurement unit and its equivalent quantity related with the request issued by SATENA.

**Alternate Part Numbers:** In the quotation must be advise the alternate part numbers offered by the provider. If after the adjudication of the offer, the provider advise that the requirement are not available or its manufacture is not possible, but, an alternate number part is offered, this situation must be advised to SATENA before the products delivery.

**Returns:** In case of the purchase not be delivered under the terms and conditions required for SATENA (Traceability, part number, shelf life, etc.) the provider will have 5 calendar days for correct the discrepancy. If during this period of time the discrepancy is not corrected by the provider, the products will be returned and additional charges will be assumed by the provider, including taxes and applicable customs charges. In addition, this one must cover the expenses related with the delivery of other product that satisfies the SATENA requirement.

**Dangerous goods certificates:** All offers of chemical products must include the issue of DG certificate if this one is required. This cost must be included in the original quotation and it will not be billed separately. This certificate must be issued from the place of origin to Bogotá, Colombia.

**AOG Fee:** In case of requirements with AOG priority where an additional payment be required, this one must be included into the issued quotation.

**Maintenance:** When the purpose of the quotation is repair/maintenance/overhaul and/or exchange, address and point of contact must be provided for the shipment of the product.

**Quote values:** prices of quotation must include two decimal units to facilitate the payment process.
